Financial Underutilisation: Only 44% of the allocated funds were disbursed between 2017-18 and 2023-24, indicating persistent financial underperformance.; Weak Implementation & Preparedness: The Ministry utilised only ₹850.71 crore out of ₹1,606.15 crore disbursed (86%) by the World Bank, reflecting non-preparedness and weak monitoring mechanisms.
